This event will examine joint response potential and novel resources among first responders, healthcare (including mental health), emergency management, business, nonprofits, military forces, and others using a catastrophic incident scenario to drive discourse. The scenario will only consider the first 24 hours following a massive earthquake in California. However, the focus will be upon solutions which have application for interstate opportunities for improvement across the United States and territories.

Topics will include interstate transport of pediatrics, hospital evacuation and transport of pediatrics, communications/situational awareness (including pediatric patient tracking and data transfer), and family reunification pertaining to pediatric patient movement from hospitals which must evacuate. The Conference will offer innovative models and facilitated discussions among leaders to foster new relationships, effective collaboration, cross-training, and increased awareness about capabilities, limitations, and diverse vernacular employed among partners who may or may not have previously planned together.

Speakers will offer insights each morning to provide the background needed for a facilitated discussion, called a **Significant Event Readiness Forum (or SERF)**. After the presentations, local government, private sector, and military responders (**day 1**) and healthcare (**day 2**) will discuss topics in a SERF environment. Federal and state partners will then respond to issues raised. Subject matter experts involved in the SERFs will be determined by the National Oversight Committee, based upon those registering for the event.

SERFs are NOT exercises; NO disaster plans are tested. The purpose of a SERF is to provide an environment for exploring opportunities along the disaster response continuum.

This event will be hosted on Zoom. Following registration and payment - and near the event dates - the link will be sent to all those who have registered. The cost of the two-day event is \$50. This conference will focus upon the first 24 hours following disaster onset.

The Goal of Day 1 is to establish a framework for understanding command structure(s) and situational awareness; identify mental health issues; The Goal of Day 1 is also to determine first responder, private sector, and military staging, triage, and transport of pediatric.

Objectives: By the end of the first day, the audience will have a better understanding of:

1. Mental health complexities pertaining to the evacuation, transport, and reception of pediatric patients;
2. California's local and state command structure(s), situational awareness, resources, limitations, and resource distribution; and
3. First responder, military, and private sector staging, triage, and ground and air transport (including routes).

The Goal of Day 2 is to identify legal issues and clarify hospital pediatric evacuation needs, considerations, resources and resource coordination (including telehealth), communications, reunification, and challenges.

Objectives: By the end of the second day, the audience will have a better understanding of:

1. Legal complexities;
2. Patient movement;
3. Healthcare capacity status identification, hospital needs assessments, communication strategies, and essential elements of information collection;
4. Transfer of patient information amongst healthcare systems;
5. Patient tracking healthcare systems and agencies supporting family reunification; and
6. Hospital pediatric patient reception best practices and challenges (including unaccompanied minors, chain of custody for minors, and altered standards of care).
